Premium Options	Limited Premium
Premium Mode	Annual or Semi Annual or Quarterly or Monthly

Important things to remember

- The premium amount is level during the term which cover death benefit and provide cash back benefits / maturity benefit for those who are surviving at the end of the term
- You have access to your money in regular intervals. Partial withdrawal and Loan facility is not available under the plan
- The sum assured under this plan is guaranteed at 3 intervals, two being during the plan term and the last one being on maturity
- There is a free look period of 15 days within which you can cancel your plan if you don't feel it's the right plan for you
- Non disclosure of material facts may lead to rejection of claims
