Monthly Market Report October 2015

After two months of volatility, Indian Equity markets posted positive monthly gain in October 2015 led by several developments both at Global as well as Domestic level. A brief list of the developments related to Economy, Politics and Policy are listed below:

- US Federal Reserve Bank kept the key rates unchanged.
- Bank of China reduced the interest rate in economy by 25bps.
- RBI reduces the repo rate by 50bps in October 2015 monetary policy.
- Key macroeconomic data from Chinese economy remained subdued pointing towards a slowing economy growth.
- Commodity prices continued to remain subdued.
- IIP for September came at 6.4%, highest in the recent time.
- CPI for September came at 4.4% on the back on the increased food inflation.

Due to all these events panning out and positive market sentiment in the global markets, Indian key Indices gained approx. 1.5% during the month.

Market Overview:

As mentioned above, Indian Equity Markets started the month on a steady note on the back of the stable global cues. During the month, most of the global indices inched up higher and Bank of Japan and European central bank hinted towards continued QE programme. Macroeconomic data from various global economies remained stable. On the back these events, most of the global market ended the month with sharp gains ranging from 4%-12%.

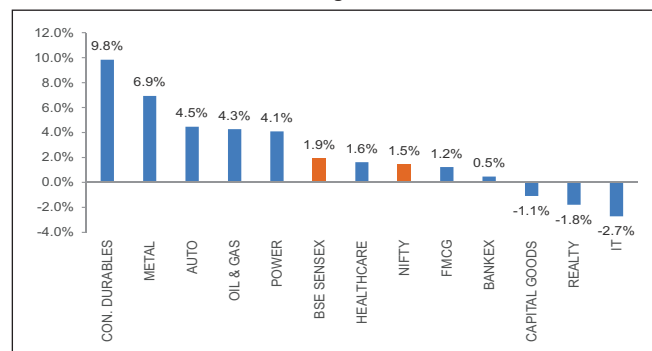
On the domestic side, Q2FY16 earnings started with a stable note amidst the expectations of the third consecutive quarter of PAT de-growth for the SENSEX 30 companies. However, the most of the result turned out to be better on the back of lower commodity cost and stable sales growth. Till 1st November 2015, 19 of the 30 Sensex companies have come out with their quarterly result and they posted combined 11% YoY growth in PAT, much higher than expectations. This has led to strong up move in the broader indices.

India's macroeconomic trends are showing gradual improvement in economic activity. Latest CPI inflation came at 4.4 percent while IIP surged to highest number in recent time. The latest print of IIP came at 6.4% percent for August 2015. Trade deficit for September 2015 came at USD10.5bn, slightly improved from August 2015. These key macroeconomic data are pointing towards a slow but steady economic recovery taking place and we may see the impact in the headline GDP numbers in next six months. We believe given the sharp increase in Government Expenditure and front loading of the same will help in giving the much needed stimulation to the economic activity. Lower government subsidies and increased tax collection should lead to lower borrowing requirement by Government. This will leave more money in economy and may also help in reducing the interest rate in the economy. This will certainly help in reviving the investment demand in the economy.

On the political and policy front, all eyes are on the election in Bihar and its consequences on the national politics importantly in the upcoming parliament session. A win for the NDA may help them to tame their opposition in parliament and may be able to pass key legislations which are needed for future

FII flow turned positive after two months of selling. During the month, FIIs mopped up equities worth of USD1022mn and Debt worth of USD 2421mn. On the other side, DIIs bought equities worth of Rs. 2935 cr in the month.

Equity Market Outlook:

At the current level of approx. 26600, Sensex is trading at 14.4x on March 2017 earnings estimate of Rs.1850 (Select Brokerage Estimates). In the current environment of the global sell off in the equities we believe Indian economy is well off due to 1) lower crude prices 2) Sharp drop in the commodity prices and 3) relatively higher dollar reserve will help the economy to steer through this uncertain time. These factors should lead to a gradual incremental positive growth for the economy and should translate into higher corporate earnings growth in a gradual manner in the coming 4 to 6 quarters. Thus we believe market valuations are not in an over stretched zone and any corrections can be used by investors to invest with a view of 3 - 5 years.

Debt Market Outlook:

The 10 year gilt yield has risen from 7.51% in the beginning of the month to 7.64% at the end of the month. The rise on the yields has been due to the likelihood of raising of rates in Dec 2015 by the Federal Reserve. Also the CPI inflation has increased (as the favourable base effect has waned). However, the macro fundamentals are favourable to interest rate softening and we expect the rates to soften further

Fund Manager's Comments

October, 2015

Fund Manager's Comments on Equity Portfolio

In the month of October 2015, most of the key global markets witnessed significant bounce back (up in the range of 3 percent to 8 percent) as investors cheered the hints of stimulus package from Bank of Japan & European Central Bank as well as the rate cut in China. On this global backdrop, the domestic markets (Nifty up 1.5 percent) remained comparatively subdued as lackluster 2QFY16 earnings season and anxiety towards outcome of Bihar elections kept sentiments jittery. On the macroeconomic front, indicators remained positive with better than estimated IIP growth of 6.4 percent and both, WPI and CPI staying within comfortable zone. FIIs continued to be net sellers in the cash segment as they offloaded equities worth of US\$ 989 mn. Going ahead, apart from the global cues and domestic macroeconomic indicators, the ongoing 2QFY16 earnings season and outcome of Bihar state elections would be key in deciding the near-term trajectory of the markets.

During the month, we continued to prefer sectors such as IT, Pharma and other consumption themes. Going ahead, we may tactically take a call on cash levels based on market movement and attractiveness of individual sectors/ companies. The exposure to equity might be tilted towards low beta stocks that are having attractive value proposition.

Fund Manager's Comments on Debt Portfolio

The 10 year gilt yield has risen from 7.51 percent in the beginning of the month to 7.64 percent at the end of the month. The rise on the yields has been due to the likelihood of raising of rates in Dec 2015 by the Federal Reserve. Also the CPI inflation has increased (as the favorable base effect has waned). However, the macro fundamentals are favorable to interest rate softening and we expect the rates to soften further, with crude oil prices being subdued and fiscal deficit under control. We will maintain duration in all the Funds.

Glossary

Standard Deviation

Standard deviation is a measure of volatility of returns of the portfolio from the average returns. The lower the standard deviation, the better it is.

Sharpe Ratio

Sharpe ratio is arrived at by dividing the returns in excess of risk-free return with the standard deviation of portfolio returns and is a measure of risk adjusted returns. Higher the Sharpe ratio, the better it is.

Portfolio Beta

Beta is a measure of volatility of the portfolio with respect to the market, also known as systematic risk. A beta measure of 1 indicates that the portfolio value moves with benchmark / market. Any value greater than 1 indicates that the portfolio is more volatile than the benchmark / market and vice versa.

Tracking Error

The tracking error is an estimation of the variability in a scheme's performance vis-à-vis the index that it tracks. This measure is used for index schemes which have an investment objective to track the performance of stated market index. Lower tracking error signifies Fund returns are close to the benchmark Index Returns

Average Maturity

Average maturity is the weighted average residual maturity of the portfolio. A portfolio consisting of longer dated security has higher average maturity.

Modified Duration

Modified duration measures the price sensitivity of a fixed income security or portfolio of fixed income securities with interest rate. It is used to determine the effect of a 100-basis-point (1 percent) change in interest rates on the value of portfolio of fixed income securities. A portfolio consisting of longer dated securities is more sensitive to the changes in interest rate as compared to a portfolio with shorter dated securities.

Credit Profile of Investments

Credit profile gives the break-up of portfolio across rating categories..

Annualized Returns

Returns calculated on an annual basis are called annualised returns. For period less than a year, returns are simple annualized. For periods more than a year, compounded annualized growth rate (CAGR) returns are used as annualized returns.

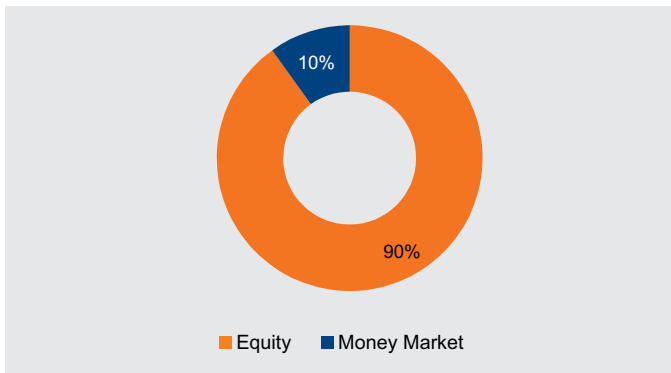

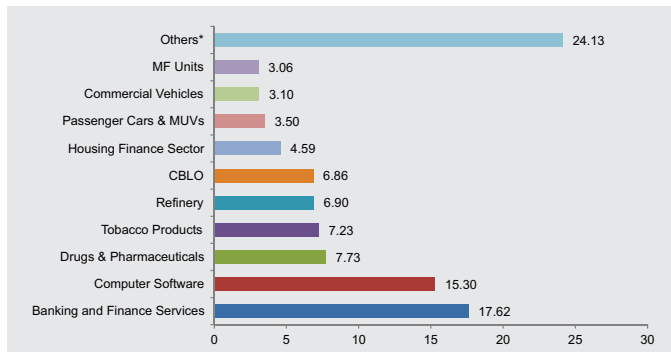

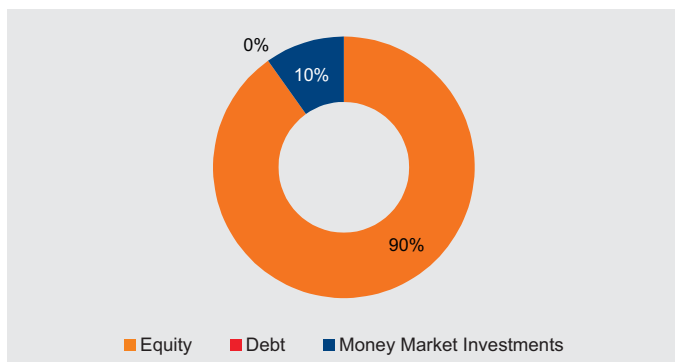

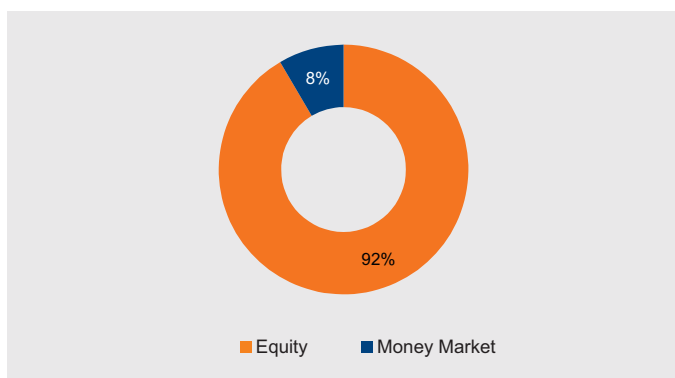

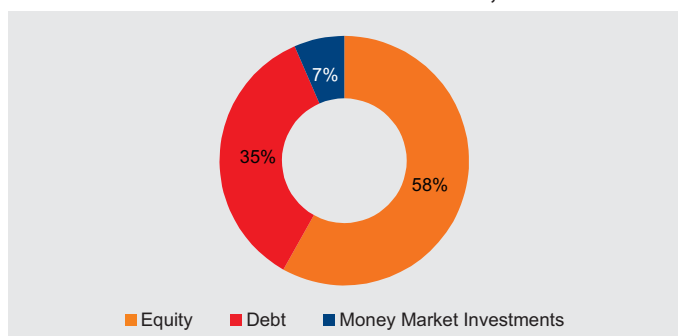

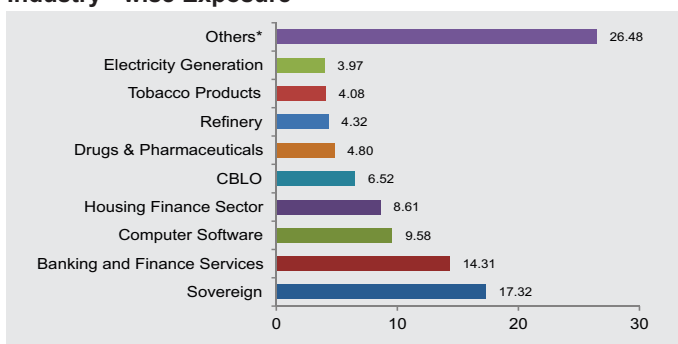
Asset Allocation Pattern as on October 30, 2015

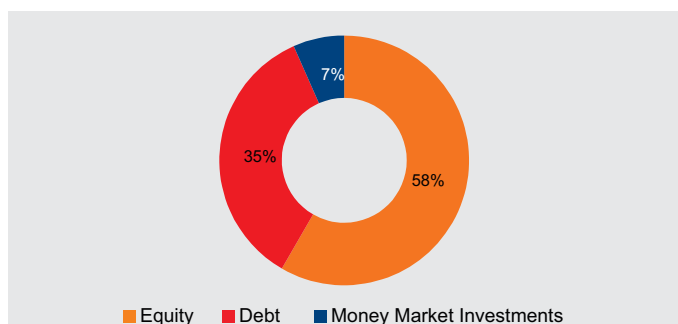

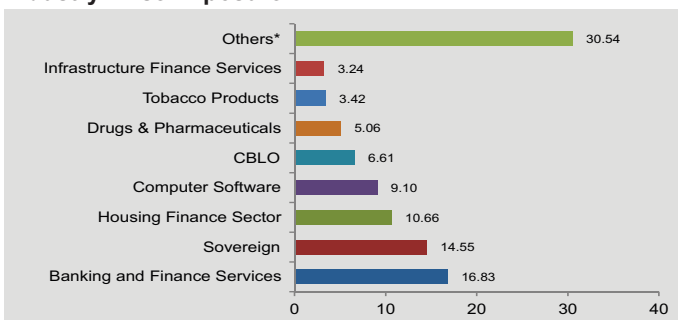
Asset Allocation Pattern as on October 30, 2015

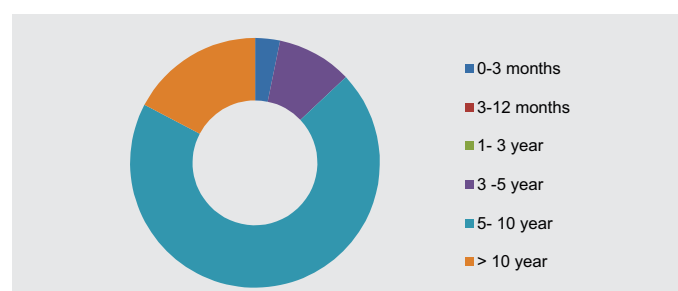

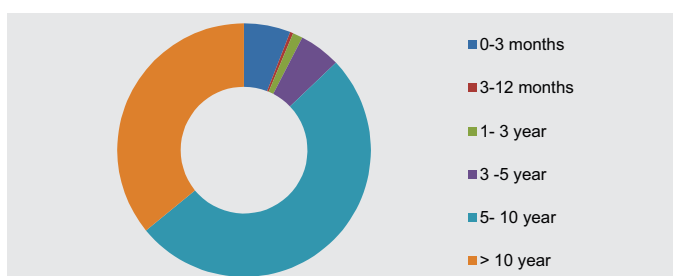

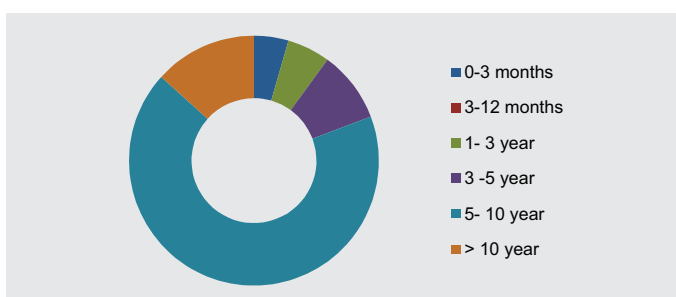

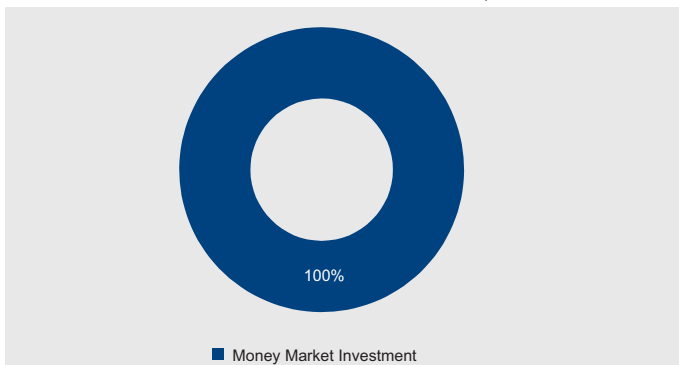

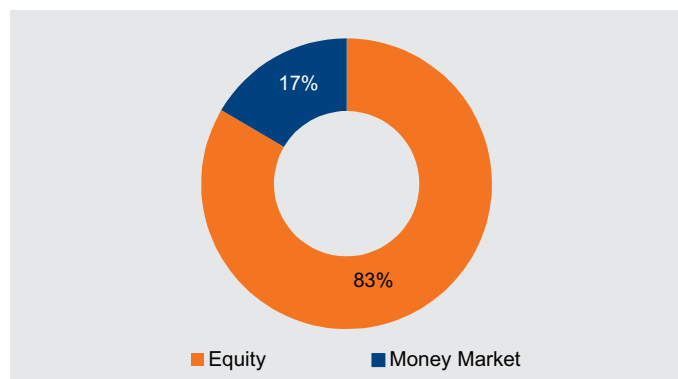

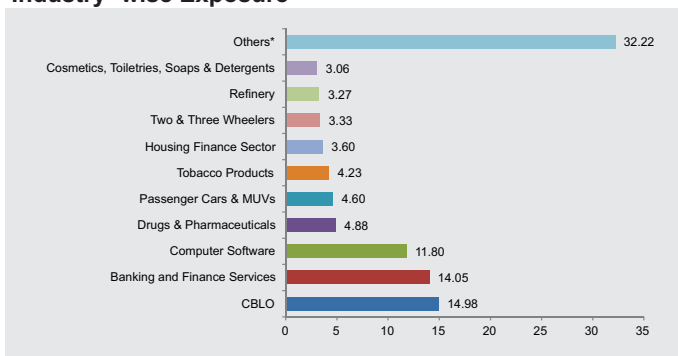

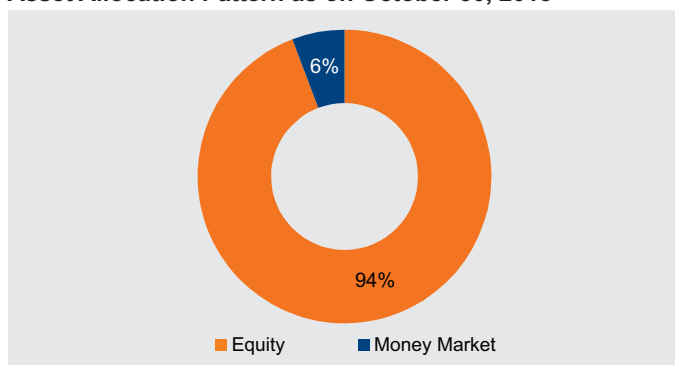

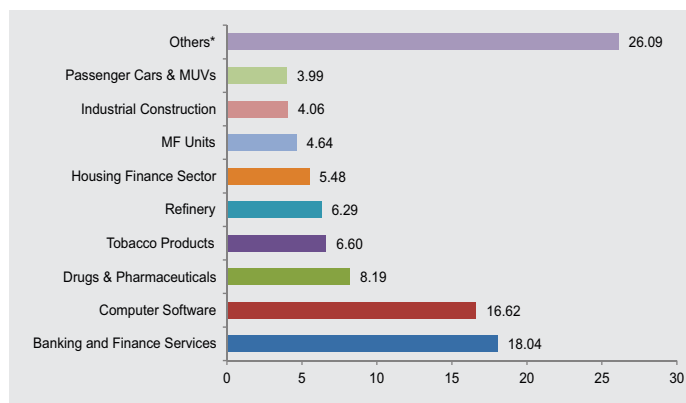

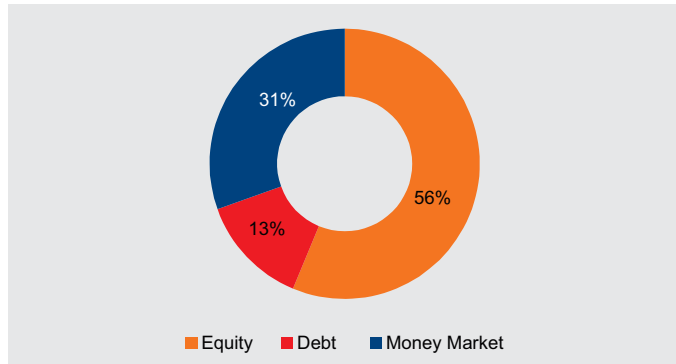

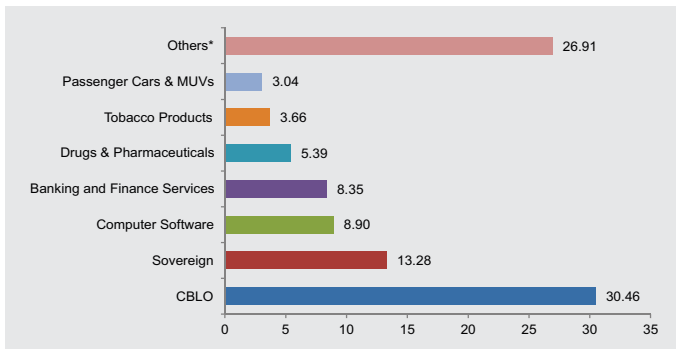
